Nutcracker Audition Times and Fees:

5.00 per student, due on or before Friday, September 13th

Saturday, September 14th

4:00 pm - 4:30 pm **Ages 7 to 9**; 4:30 pm - 5:00 pm **Ages 10 -12**

**Casting will be posted Tuesday, September 17th by 6:00 pm on ddccompany.org*



Audition Requirements: Must be enrolled in one (1) ballet, jazz or modern class.

Participation Fee: If casted, the participation fee is \$75 per dancer. This covers all rehearsal time, costume rental, and a 2019 Nutcracker T-shirt Souvenir (includes all participating dancers' names on the back). **Due on or before Saturday, September 24th.**

Mandatory Parent Meeting: During the Nutcracker Auditions, Saturday, September 14th 4:00-5:00, we will hold a Mandatory Parent Meeting to discuss the requirements and commitment required to participate, and also answer any questions you may have.

Rehearsal and Performance Information:

- Rehearsals will occur Saturday afternoons, between the hours of 12:30 - 5:00 pm, Saturday, September 21 – Saturday, November 30th. Exact times will be announced at the parent meeting on Saturday, September 14th.
- *Tech Rehearsals and the Nutcracker will either be November 22-24 or December 6-8.* If casted, please be informed that ALL Nutcracker Rehearsals, Tech Rehearsals, and Performances are mandatory, no exceptions.
- Only ONE absence will be excused throughout the duration of rehearsals; however, absences are NOT allowed for tech rehearsals and/or both performances. More than ONE absence from a scheduled Nutcracker rehearsal will result in your child's role being immediately & permanently reassigned to another student. No Exceptions.
- Faculty of the company, and the company Parent Volunteers, are committed to making participation in this year's production of the Nutcracker both fun and memorable; however, participation does require a total commitment from both the parents and the student dancers. If you are not willing and able to commit your weekends from September through December 2019, please carefully reconsider before allowing your child to audition.
